ISSA shall offer to sell each of the plot for \$6,160 (GST inclusive).

In order for ISSA to effectively process a pre-purchase application, interested parties are required to pay either the full amount or the deposit (GST inclusive) per plot. An **invoice will be issued upon receipt of the completed Expression of Interest form**, and payment is to be made using the invoice details provided.

All payments are strictly non-refundable once payment has commenced.

Family will need to contact a monumental mason for a detailed, itemised quote, as prices vary between vendors and depend on the design and inscription. At Smithfield Memorial Park, only simple headstones are permitted to comply with Islamic practice and to standardise the look across the Muslim burial section. Large monuments or decorative structures are not encouraged.
